I, the undersigned individual, acting as the incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation:

## PALOUSE-CLEARWATER ENVIRONMENTAL INSTITUTE INCORPORATED

#### Article 1 - Name

The name of this corporation is Palouse-Clearwater Environmental Institute Incorporated; hereafter called PCEI.

#### Article 2 -Duration

The period of duration of this corporation is perpetual.

#### Article 3 - Purpose

This corporation is organized exclusively for the promotion of social welfare for educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Such purposes shall include:

- A. To identify ,study and educate citizens of the Pacific Northwest on the economic, social, health and environmental costs, consequences and impact of the nuclear age.
- B. To provide forums for exchange of views on these matters of concern to the public;
- C. To carry on research and to make such research available for the benefit of the general public;
- D. To inform and educate the public on issues of importance to the future of the Northwest and thus create a well-informed, active, and concerned citizenry.

#### Article 4 - Nonprofit Nature

A. This corporation is not organized and shall not be operated for the private gain of any person. The property of this corporation is irrevocably dedicated to charitable purposes, and no part of the assets receipts, or net earnings of this corporation shall ever inure to the benefit of, or be distributable to ,any individual. This corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

- C. Any trustee or the entire board of trustees may be removed from office, with or without cause, by a majority vote of the membership of Palouse-Clearwater Hanford Watch at a meeting called expresely for that purpose and having a quorum of one-third the registered members.
- D. Corporate officers shall be elected by PCEI board to include a president, vice-president, secretary, and treasurer as provided by the charter and bylaws. Any two or more offices may be held by the same person except for the office of president and secretary.
- E. There will be no general membership in this corporation however the board must be approved by the general membership of Palouse-Clearwater Hanford Watch as provided in PCEI charter and bylaws.

#### Article 7 - Registered Agent and office

#### Article 8 - Amendments

These Articles may be amended by a two-thirds vote of the Board of Trustees.
