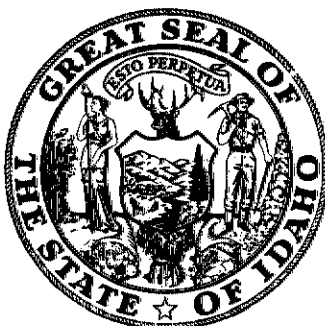

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, being all of the directors and shareholders of INTERNATIONAL INVESTMENTS, INC., an Idaho corporation ("Corporation"), under and pursuant to the provisions of the general corporation laws of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby amend the articles of incorporation of INTERNATIONAL INVESTMENTS, INC., as follows:

1. NAME. The existing name of the corporation is International Investments Inc. The name shall be changed to Foreclosure, Inc.

2. AMENDMENT TO ARTICLES. ARTICLE I of the Articles of Incorporation of International Investments, Inc. is hereby amended to change the name of the Corporation from International Investments, Inc., to Foreclosure, Inc., by deleting the existing Article I and inserting in its place the following:

ARTICLE I

The name of the corporation shall be:

FORECLOSURE, INC.

3. DATE OF ADOPTION. The above referenced amendment was unanimously adopted by the shareholders of the Corporation effective the 30th day of November, 1994.

4. ARTICLES TO REMAIN EFFECTIVE. Except as amended hereby, the articles of incorporation remain unchanged and are and shall remain in full force and effect, and, together with the amendment enunciated herein, supersede the original and any supplemental articles of incorporation of International Investments, Inc.
