KNOW ALL MEN BY THESE PRESENTS: That, I, the undersigned, being natural person of full age and citizen of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the General Corporation Laws of the State of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

ARTICLE I

That the name of the corporation is Ada Storage, Inc.

ARTICLE II

The corporation shall have a perpetual existence.

The corporation is organized for any lawful purpose or purposes permitted by law.

ARTICLE IV

The corporation shall have authority to issue five thousand (5,000) shares; all such shares to be of one (1) class of common stock, and to be of no par value.

The private property of the stockholders of the corporation shall not be subject to the payment of corporation debts to any extent whatsoever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation.

The number of directors of the corporation shall be as specified in the By-Laws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws.
