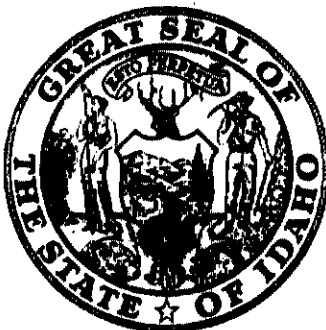
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

S AND S CONSTRUCTION CORPORATION

The undersigned, action as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ~~S and S Corporation~~ S AND S CONSTRUCTION CORPORATION

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 with a par value of \$1.00 per share.

FIFTH: There are no provisions denying preemptive rights.


