ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

DOUGLAS E. SMITH, M.D., P.A.

The following amendment to the Articles of Incorporation of Douglas E. Smith, M.D., P.A., an Idaho professional service corporation whose Articles of Incorporation were originally filed in the office of the Secretary of State on December 19, 1994, was duly adopted by the action of the sole shareholder of said corporation in accordance with Idaho Code Sections 30-1-59 and 30-1-145.

Pursuant to Idaho Code Section 30-1-61, the undersigned President and Secretary of the corporation state:

- (a) The name of the corporation is Douglas E. Smith, M.D., P.A.
- (b) The amendment adopted is to delete Article I of the Articles of Incorporation and substitute the following therefor:
