**I**

The name of the corporation is **G.B.R. BUILDERS-DESIGNERS, INC.**

**II**

The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho, as they may be amended from time to time.

**III**

The corporation initially intends to conduct the business of investments.

**IV**

The duration of the corporation shall be perpetual.

**V**

The corporation shall have authority to issue a total of One Hundred Thousand (100,000) shares of Common Stock with a par value of One Dollar (\$1.00) per share.

**VI**

The holders from time to time of the common stock of the corporation will have preemptive rights as to the stock. No resolution of the Board of Directors authorizing the issuance of stock to which preemptive rights attach may require such rights to be exercised within less than sixty (60) days.

**VII**

The known place of business of the corporation will be P.O. Box 3601, Hayden, Idaho 83835.

**VIII**

The affairs of this corporation will be managed by a Board of Directors of not fewer than two (2) nor more than seven (7) Directors. Within such limits, the number of Directors shall be fixed and may be altered from time to time as provided by the By-laws.
