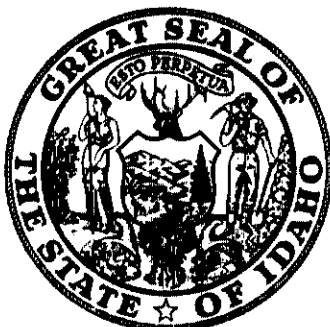
### CERTIFICATE OF AMENDMENT OF

ARTICLE OF AMENDMENT OF  
ARTICLES OF INCORPORATION OF  
APPLIED ELECTRONICS COMPANY

KNOW ALL MEN BY THESE PRESENTS, that at a special meeting of the stockholders of APPLIED ELECTRONICS COMPANY held on the 28<sup>th</sup> day of May, 1993, pursuant to a written waiver of notice and consent of stockholders of the corporation, the following resolution was unanimously adopted by vote of approval of all the stockholders of the corporation:

BE IT RESOLVED that the Articles of Incorporation of APPLIED ELECTRONICS COMPANY be, and the same are hereby, amended and modified as follows:

Article IV of said Articles of Incorporation shall be amended to increase the capitalization of the corporation to 3,500 shares at par value \$1.00, and shall read as follows:

"FOURTH

The aggregate number of shares which the corporation has the authority to issue is 3,500 (Three Thousand Five Hundred) shares of common stock, all of one class, at par value of \$1.00 (One Dollar) each."

All other articles of the said Articles of Incorporation of APPLIED ELECTRONICS COMPANY shall remain the same and shall not be amended or modified in any way except as the same appear to this date.

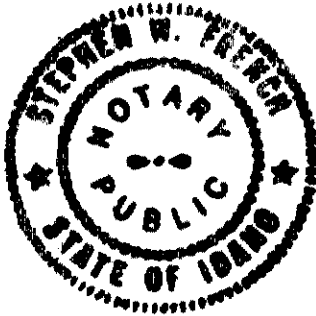
