TO

ARTICLES OF INCORPORATION

The undersigned, Larry Grover, president, and W. R. Parker, secretary, of Idaho Implement, Inc., do hereby certify and respectfully represent as follows:

That Idaho Implement, Inc. is an Idaho corporation, duly organized and existing under the laws of the State of Idaho, having been incorporated the 3rd day of January, 1983; that a meeting of the stockholders of Idaho Implement, Inc. was duly called by written notice given by the secretary thereof more than 30 days prior to the date set for such meeting to each share stockholder, and that such notice was to the effect that the stockholders would be called to act upon a proposed Amendment to the Articles of Incorporation as to the authorized capital stock of the corporation.

That such stockholders meeting of Idaho Implement, Inc. was held on the 28th day of June, 1983, at Idaho Falls, Idaho, at which meeting all of the holders of the outstanding shares of stock of the corporation were present in person and in attendance throughout the entire meeting; that the shareholders so present are also the directors of the corporation; that by affirmative unanimous vote of all the shareholders of the corporation there was adopted a resolution amending the Articles of Incorporation as hereinafter set forth.

That the resolution adopted by the stockholders amending the Articles of Incorporation is as follows:

RESOLVED, that Article IV. of the Articles of Incorporation of Idaho Implement, Inc. be amended to read as follows:

ARTICLE IV.

The amount of the capital stock of this corporation shall be \$100,000.00 divided into 10,000 shares of the par value of Ten (\$10.00) Dollars each.

FURTHER RESOLVED, that the president and the secretary of the corporation be, and they hereby are, authorized, empowered and directed to take the necessary action to accomplish this Amendment to the Articles of Incorporation of this corporation.
