ARTICLES OF INCORPORATION

OF

HYNES LABOR CAMP, INC.

WE, THE UNDERSIGNED, being five natural persons of full age, all of whom are natural citizens of the United States of America, do hereby voluntarily associate ourselves for the purpose of forming a nonprofit corporation under Title 30, Chapter 10, Idaho Code, and other applicable laws of the State of Idaho, and WE HEREBY CERTIFY:

ARTICLE I

That the name of this Corporation shall be HYNES LABOR CAMP, INC.

ARTICLE II

That the existence and duration of this corporation is and shall be perpetual.

ARTICLE III

That this corporation is not organized for and does not contemplate pecuniary profit to or for itself or its members.

ARTICLE IV

That the location and post office address of the registered office of this corporation in the State of Idaho is Rt. 2, Paul, Idaho.

ARTICLE V

That the purposes for which this corporation is formed are as follows:

To render constructive services for the promotion and availability of farm labor to the community of Paul, Idaho, and surrounding area, and the citizens thereof; to provide housing for farm laborers, to make available to the farmers of the community and surrounding counties of Jerome, Minidoka and Lincoln farm

laborers to assist the farmers in the area; to provide a central location for the employment of farm workers; to foster and promote the general farm business interests of the counties surrounding said community, and to improve, extend and place upon a sound and permanent foundation the general farm labor problems and provide farm laborers where and when required in sufficient numbers; to lease, purchase, hold, have, use and take possession of and enjoy in fee simple or otherwise any real or personal property reasonably necessary for the uses and purposes of the corporation; and to sell, lease, deed in trust, or dispose of the same at the pleasure of the corporation; and to buy and sell personal and real property and apply the proceeds, including any and all income, to the uses and purposes of the corporation; and to do any and all things necessary to promote, or the objects of which are to promote, the purposes of the general welfare of said corporation and the community of Paul, Idaho, and surrounding counties of Minidoka, Lincoln and Jerome, Idaho, as is or may be related to employment, use, availability and presence of farm laborers under the purposes and objects of this corporation.

#### ARTICLE VI

That this corporation shall not issue any capital stock, but shall issue membership certificates to each member hereof under such regulations as may be prescribed by such corporation in its By-laws or otherwise; provided, however, the rights and interests of the members are and shall be equal, and no member can have or acquire a greater interest in said corporation than any other member.
