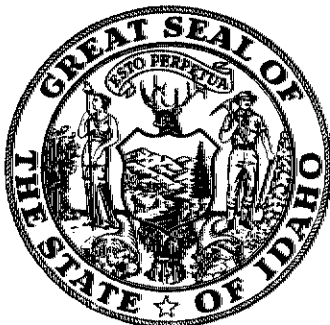

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

I. The name of the corporation is Mountain West Dental Company, Inc. (the "Corporation").

II. Article V of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:


"The corporation shall be authorized to issue shall be 10,000 shares of non-assessable common stock without par value."

VI. There are presently issued and outstanding 5,432 shares of the Company's \$100.00 per share par value stock for a total Stated Capital Account, as that term is defined at Idaho Code Section 30-1-1 (j), of \$54,320.00. The effect on stated capital of the above amendment will be to change the former \$100.00 par value shares outstanding to no par value shares and thus to reduce to the Stated Capital Account to zero.
