

CERTIFICATE OF AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF THE

PLACER CREEK SILVER-LEAD MINING & MILLING CO.

We, the undersigned, F. C. Bailey and  
E. P. Woodquist, Chairman and Secretary respectively  
of that certain meeting of the stockholders of the above named  
Company, held at the office of the company on August 9th, 1922  
at ~~eight~~ <sup>seven</sup> o'clock ~~P.M.~~ <sup>P.M.</sup> as hereinafter described, do hereby certify  
that at said meeting the Articles of Incorporation of the  
Company were amended as hereinafter set forth, and that the  
following proceedings have been had in connection therewith:-

(1) That the Board of Directors of the said Placer Creek  
Silver-Lead Mining and Milling Co. met in regular session at the  
office of the Company on the 26th day of June 1922,  
and by a majority vote of the directors of said corporation,  
it was resolved and ordered that a special meeting of the  
stockholders of said company be called for August 9th 1922 at  
eight P.M. at the office of the company for the purpose of  
amending the articles of incorporation by changing the name of  
the company, and for the purpose of electing directors to fill  
the vacant places of the Board of Directors.

(2) That pursuant to the said call by the board of direc-  
tors, a written notice signed by the secretary F. C. Bailey, stating  
the time and place of the meeting and the object thereof was  
mailed personally to each and every stockholder thereof at his  
recorded address at least 30 days prior to said meeting, AND  
a notice stating the time and place and object of the meeting  
was published once a week for thirty days prior to the date of the  
meeting in the Wallace Miner, a legal newspaper pub-  
lished in Shoshone County, Idaho, where the principal place of  
business, and the property of the company, are located, first

publication being on July 6th and last publication being on July 27th 1922;

(3) That pursuant to the proceedings hereinbefore set forth, and on the 4th day of August at 8 P.M., 1922 the stockholders of the said Placer Creek Silver Lead Mining and Milling Company met in special session at the office of the company <sup>and adjourned to Aug. 9th 1922 at 12 o'clock noon</sup> as above set forth, at which meeting a total of 265,000 shares were represented; that the said number of shares represented more than two thirds of the entire authorized capital of said corporation on said day; that the following resolution was thereupon moved, seconded and carried:-

"BE IT RESOLVED That Article One (1) of the articles of incorporation of this company be amended to read as follows:

"The name of this corporation shall be  
SILVER CRESCENT MINING COMPANY"

that upon the question of the adoption of the above resolution the vote resulted as follows:-

For 265,000 votes

Against 265 votes.

That said motion was carried by a vote of more than two thirds of the entire capital stock of said corporation, as set forth above, and that the chairman of the meeting thereupon declared the motion unanimously carried and adopted.
