ARTICLES OF INCORPORATION

OF

IDAHO SNOW RIDERS SNOWMOBILE CLUB, INC.

know all Men by these presents, that we, the undersigned, being natural persons of full age and citizens of the United States and of the State of Idaho, have this day voluntarily associated ourselves for the purpose of forming a non-profit cooperative association under Title 30, Chapter X of the Idaho Code and to that end do hereby adopt articles of incorporation as follows:

Ī

NAME: The name of the corporation is IDAHO SNOW RIDERS SNOWMOBILE CLUB, INC.

II

PURPOSE: The purposes for which said corporation is formed are:

- (A) To promote the use of snowmobiles for pleasure and to conduct snowmobile trail meets and other snowmobile activities and a snowmobile safety program.
- (B) To acquire by purchase or lease land or otherwise acquire interest in land and to own, hold, improve, develop and to manage any real estate so acquired for the purpose of this corporation and to erect on such land owned, leased or otherwise held and occupied by the corporation, such buildings and other structures with their appertuances and to do all things necessary to promote the purposes of this corporation as set out hereinabove
- (C) To sponsor prizes and sell tickets and use other methods of raising revenue to assist in the programs of the corporation.

(D) To set out snowmobile courses and search and rescue missions.

III

PERIOD OF DURATION: The corporation is to have perpetual existence.

IV

PLACE OF BUSINESS: The location and post office address of the registered corporation is 940 North Ninth East Street, Mountain Home, Idaho.

v

payment of a membership in this corporation shall be by payment of a membership fee of not less than \$7.00 per annum. Membership qualifications shall be determined by the by-laws adopted by the members at the annual meeting of the corporation. Any member of the Idaho Snow Riders Snowmobile Club with a paid-up membership for 1968-1969 may become a member by application. Membership cannot be transferred or assigned. The rights and interests of all members shall be equal.

AMENDMENTS: The corporation reserves the right to amend, alter, change or repeal any provision contained in this certificate of incorporation in the manner now or hereinafter prescribed by law, and all rights and powers conferred on the members, directors and officers are subject to this reserve power. These articles may be amended by resolution setting forth such amendment or amendments, adopted at any meeting of the membership at which 50% of the membership attends by a vote of the two-thirds (2/3) majority of the quorum attending.

officers: Until the first annual meeting of the members and the election and qualification of the officers, Joanna M. Drake shall serve as President; Eugene Claude shall serve as Vice President; Ruth Claude shall serve as Treasurer; Alice Obenchain shall serve as Secretary; and Jack Noble shall serve as Director.

IX

ELIGIBILITY OF OFFICERS: To be eligible to any of the above-named officers of this corporation, a person must be a member in good standing throughout the period during which such office is held.

BOARD OF DIRECTORS: Until the first annual meeting of the members and the qualification of the directors, Joanna M. Drake, Jack Noble, Eugene Claude, Alice Obenchain, Ruth Claude and Donal Williams shall serve as directors. The board of directors shall consist of no more than six members.
