# ARTICLES OF INCORPORATION

OF

T. I. P., INC.

Know All Men by These Presents: That the undersigned,
C. L. TURNER, HELEN TURNER, RICHARD W. TURNER, PATRICIA TURNER,
JOHN R. IRWIN, VELMA IRWIN, C. SIDNEY PIPER and YVONNE PIPER,
each of whom is a citizen of the United States of America,
have associated themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and
in pursuance thereof do hereby sign and acknowledge the following Articles of Incorporation, in triplicate originals, and
state as follows:

## ARTICLE I.

The name of the corporation shall be T. I. P., INC.

ARTICLE II.

The general nature of the business of the corporation and the objects and purposes proposed to be transacted, promoted and carried on by it are as follows:

- (1) To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in lands and leaseholds and any interest, estate and rights in real property and any personal or mixed property.
- (2) To manufacture, buy, sell, deal in and to export and import, conduct and carry on the business of manufacturing, buying, selling, importing and exporting goods, wares and merchandise of every class and description, both at wholesale and retail.

- (3) To purchase or otherwise acquire, so far as permitted by law, the whole or any part of the undertaking and business of any person, firm or corporation engaged in a business of the same general character as that for which this corporation is organized, and the property and liabilities, including the good will, assets and stock in trade thereof, and to pay for the same either in cash or in shares, or partly in cash and partly in shares.
- (4) To deal in and with any franchises, rights, business or privileges necessary, convenient and appropriate for any of the purposes herein expressed.
- (5) To acquire by purchase, subscription, or otherwise, and to hold for investment or otherwise, and to use, sell, assign, transfer, mortgage, pledge or otherwise deal with or dispose of stocks, bonds or any obligations or securities of any corporation or corporations; and to merge or consolidate with any corporation in such manner as may be provided by law.
- (6) To borrow money, and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds, whether secured by mortgage, pledge or otherwise, without limit as to amount, except as may be prohibited by statute, and to secure the same by mortgage, pledge or otherwise, and generally to make and perform agreements and contracts of every kind and description.
- (7) To conduct and carry on its business, or any part thereof, and to have one or more offices, and to exercise all or any of its corporate powers and rights in the State of Idaho, and in the various states.
- (8) To do all and every thing necessary, suitable and proper for the accomplishment of any of the purposes, or the

attainment of any of the objects, or the furtherance of any of the powers hereinabove set forth, either alone or in association with other corporations, firms or individuals, and to do every act or acts, thing or things, incidental or appurtenant to or growing out of or in connection with the aforesaid business or powers, and/or any part or parts thereof; provided the same be not inconsistent with the laws under which this corporation is organized.

#### ARTICLE III.

The corporation is to have perpetual existence.

#### ARTICLE IV.

The registered office of the corporation is to be located at Rockford Bay, Idaho; and that address is also to be the post office address of this corporation.

# ARTICLE V.

The authorized capital stock of the corporation shall be Fifty Thousand (\$50,000.00) Dollars, consisting of Fifty Thousand (50,000) Shares of common stock having a par value of One (\$1.00) Dollar each. Each share of stock shall have the same voting right as every other share, and no share of stock shall have any rights other than any other share of stock.

### ARTICLE VI.

The management of this corporation shall be vested in a Board of Directors; the number of directors shall not be less than three (3) nor more than nine (9), and the number, qualifications, terms of office, manner of election, time and place of meeting, and powers and duties of the directors shall be such as are prescribed by the By-Laws of the corporation.

# ARTICLE VII.

The authority to make By-Laws for the corporation is hereby expressly vested in the Board of Directors of this corporation,

subject to the power of the shareholders to change or repeal such By-Laws. The board of directors shall not make or alterany By-Laws fixing their qualifications, classifications, terms of office or compensation.

## ARTICLE VIII.

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred on the stockholders herein are granted subject to this reservation.
