ARTICLES OF AMENDMENT  
OF THE  
ARTICLES OF INCORPORATION  
OF THE  
FIRST METHODIST EPISCOPAL CHURCH OF FILER

We, the undersigned, the Chairman and Secretary, respectively of the First Methodist Episcopal Church of Filer, Idaho, an Idaho Corporation, hereby certify that at a regular meeting of the members of this corporation duly called and held on the 6th day of April, 1954 after notice was published in the Citizen-Record, a newspaper published in Filer, Idaho for four consecutive weeks and also posted in a conspicuous place on the church building for a like period in accordance with the statute of the State of Idaho and the By-laws of this corporation, the following resolutions were adopted by the vote of more than a two-thirds majority of the members of this corporation present at this regular meeting, the resolutions being as follows:

1st. Be it resolved that Article I be, and it hereby is amended in its entirety to read as follows:

The name of this corporation shall be the FIRST METHODIST CHURCH OF FILER, IDAHO, INCORPORATED.

2nd. Be it resolved that Article II be, and it hereby is amended in its entirety to read as follows:

The purpose for which this corporation is formed is to establish and maintain a church organization and a house of worship of the Methodist denomination in the town of Filer, County of Twin Falls, State of Idaho, and in connection therewith to form and maintain suitable and customary organizations for the purpose of public worship and religious training, and works of charity, subject to the provisions of the Discipline and the usage and ministerial appointments of the Methodist Church as from time to time authorized and declared by the General Conference of said Church and the annual Conference within whose bounds such corporation is situated, under the supervision of Martindale Woods, the pastor and his successors, to take title and charge of buildings, estate and property, and the affairs of the temporalities thereof and to sell and otherwise dispose of the same.

3rd. Be it resolved that Article III be, and it hereby is adopted in its entirety as follows:

The principal place of business of this corporation shall be the Town of Filer, County of Twin Falls, and the State of Idaho.

4th. Be it resolved that Article IV be, and it hereby is amended in its entirety to read as follows:

The term of this corporation shall be perpetual.

5th. Be it resolved that Article V be, and it hereby is amended in its entirety to read as follows:

The number of trustees who shall have the management of its affairs as aforesaid shall be 9 and the names of the trustees for the ensuing year are:

6th. Be it resolved that Article VI be, and it hereby is adopted in its entirety as follows:

Profit or speculation not being the object for which this corporation is organized, there is no capital stock or shares issued.

7th. Be it resolved that Article VII be, and it hereby is amended in its entirety to read as follows:

The members of the corporation having the right to participate therein and to elect directors and officers are, and shall be the members in good standing of the First Methodist Church of Filer, Idaho, Inc.; and the qualifications of the trustees shall be such as are and shall be prescribed by the rules and regulations and Discipline of the religious denomination known as the Methodist Church. The trustees above named, who are to serve until their successors are duly elected according to the Discipline of the Methodist Church, have been duly elected and appointed, at a meeting of the members of the Church, duly convened and held according to the rules and Discipline of the Methodist Church at Filer, Twin Falls County, Idaho, on the 6th day of April, 1954, for the purpose among other things of electing said trustees and amending the articles of incorporation. That a majority of said members who were then and there present, and voted at said election for said trustees, as is more particularly set forth in the certificate and verification of the officers who conducted said election hereto annexed and made a part of this instrument.
