KNOW ALL MEN BY THESE PRESENTS: That I hereby make and sub-
scribe these "ARTICLES OF INCORPORATION" for the purpose of forming
a Corporation under the laws of the State of Idaho.

AND I HEREBY CERTIFY:

FIRST. That the name of said Corporation is RIGBY FIFTH
WARD OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, INC.

SECOND. That the purposes for which it is formed is to pur-
chase, acquire and hold real and personal property, for religious,
educational and charitable purposes, within the State of Idaho.

THIRD. That the estimated value of the property, the legal
title to which is vested in the party subscribing these articles is
the sum of Eighty-five Thousand and no/100 (\$85,000.00) Dollars.

FOURTH. That the title of the person making these articles
is the Bishop of the Rigby Fifth Ward of the Church of Jesus Christ
of Latter-Day Saints, Inc.
