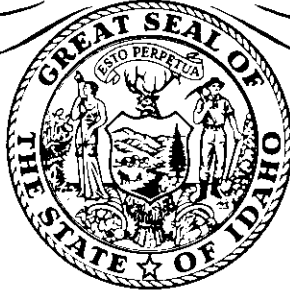

KNOW ALL MEN BY THESE PRESENTS, That we, M. L. Hunter, President and Thomas O. Cartmel, Secretary of SERVICE ASSOCIATES, INC., a corporation organized and existing under the provisions of the Business Corporation Act of the State of Idaho, DO HEREBY CERTIFY:

FIRST: That a meeting of the shareholders of the above named corporation was held on the 1st day of December, 1972, for the purpose of taking action upon a proposed amendment to the Articles of Incorporation of the said corporation pursuant to written waiver of notice signed by all shareholders entitled to vote on the proposed amendment.

SECOND: That at said meeting the following resolution amending the Articles of Incorporation of said corporation was offered:

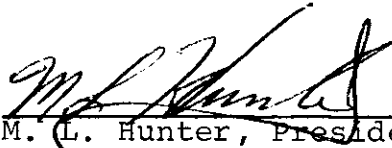
"RESOLVED that Article Fourth of the Articles of Incorporation of Service Associates, Inc. be, and hereby is amended to read as follows:

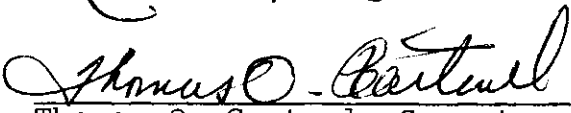
ARTICLE FOURTH: The location and post office address of its registered office in the State of Idaho is 300 North 6th Street, Boise, Idaho 83701.
