(d) To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or other individuals, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers or any part thereof, and to exercise and have all powers granted to or conferred upon business corporations by or under the laws of the State of Idaho or any other state in which the corporation may qualify to do business.

THIRD

That the existence of this corporation is to be perpetual after the time of its incorporation, unless sooner dissolved or disincorporated pursuant to law.

FOURTH

That the principal place of business and the registered office of this corporation in this state shall be in the City of Idaho Falls, Bonneville County, State of Idaho.

FIFTH

That the total authorized capital of this corporation shall be \$100,000.00 divided into 100,000 shares, with a par value of \$1.00 per share. All stock shall be common stock and when fully paid, shall be non-assessable and not subject to call. Each share of stock shall be entitled to one vote.

SIXTH

That the total authorized capital stock shall be available to the incorporators to have and hold, dispose or sell, except as public sale and consistent with the laws of the State of Idaho and following are the names of the incorporators, their addresses and the number of shares subscribed by each, to-wit:

That the management of this corporation shall be vested in a board of not less than three directors, as may be fixed by the By-Laws. Until such election, the directors of this corporation shall be: Edward B. Clark, Patricia L. Clark, and Clyde J. Hinkley Sr.

The By-Laws may be adopted by the shareholders and, also, by the board of directors in the manner provided for by the laws of the State of Idaho.
