ORDER OF DISINCORPORATION

Now, on this 21st day of August, A. D. 1916, this cause coming on regularly to be heard upon the voluntary application of SNOW STORE MINING COMPANY, a corporation, to dissolve and disincorporate; said petition duly signed and verified having been heretofore presented to the above entitled court and filed with the clerk thereof as provided by law, and more than thirty (30) days' notice having been given by the clerk by publication thereof as ordered by the court and as prescribed by law, as shown by proof of publication duly filed herein; and no person having filed objections to said application at any time before the expiration of the time of publication of said notice, or at all, and no one having appeared in any way to contest said application, and the time of publication of said notice having expired; and the court having heard the testimony and being fully advised in the premises; finds that said corporation, SNOW STORE MINING COMPANY, has taken all necessary preliminary steps and obtained the necessary vote to dissolve itself in accordance with the statutes and laws of the state of Idaho, and that all claims against said corporation have been fully paid and discharged; and that said SNOW STORE MINING COMPANY is entitled to an order declaring it dissolved, now, therefore, it is

ORDERED, ADJUDGED and DECREED that said SNOW STORE MINING COMPANY be, and the same is hereby declared to be dissolved and disincorporated, and that the directors and officers of said corporation be, and they are hereby discharged and fully released from any and all liability relative thereto, excepting the collection of any outstanding debts, obligations or assets belonging to said company, and after the payment of the necessary costs in connection herewith, the distribution of the same, together with other funds that may be on hand, be voted among the stockholders of said company.
