#### PLAN OF CONVERSION TO LIMITED LIABILITY COMPANY

THIS PLAN OF CONVERSION (this "Plan") is hereby adopted this 20th day of March, 2019, by Gem Prep: Pocatello, Inc., an Idaho nonprofit corporation (the "School").

#### RECITALS

WHEREAS, the Company is an Idaho corporation, formed March 23, 2015; and

WHEREAS, the Board of Directors of the Company (the "Board") desires to convert the Company to Gem Prep: Pocatello, LLC, an Idaho limited liability company ("GPP LLC").

NOW THEREFORE, the Board hereby adopts the following:

- 1. The Board hereby approves the conversion of the School to GPP LLC (the "Conversion").
- 2. The Board intends the School to continue its existence as an Idaho limited liability company after its conversion to GPP LLC.
- 3. GPP LLC shall assume all of the School's obligations under existing loans, bonds and other indebtedness
- 4. The Idaho Statement of Conversion converting the School to GPP LLC is attached as Exhibit A.
  - 5. The Idaho Certificate of Organization for GPP LLC is attached as **Exhibit B**.
  - 6. The Conversion shall be effective July 1, 2019.
- 7. Pursuant to Idaho Code §33-601(4)(b), the Board determines it to be in the interest of the School to transfer all real and personal property to GPP LLC without consideration.
