ARTICLES OF AMMENDMENT

H & Q ENTERPRISES, INC.

'ON THIS 20TH DAY OF DECEMBER 1983, ALL SHAREHOLDERS OF RECORD MET AND VOTED UNANIMOUSLY TO ADOPT THE FOLLOWING AMMENDMENT TO THE ARTICLES OF -INCORPORATION OF H&Q ENTERPRISES INC. WHICH DESIGNATES THAT TWO CLASSES, VOTING AND NON-VOTING, OF COMMON STOCK SHALL BE ESTABLISHED.

AMMENDMENT TO THE ARTICLES OF INCORPORATION OF . H & Q ENTERPRISES, INC.

ARTICLE NUMBER 5

(a) THAT THE AMOUNT OF THE CAPITAL STOCK OF THIS CORPORATION SHALL BE \$2,000.00 DIVIDED INTO 800 SHARES OF VOTING COMMON STOCK AND 1,200 SHARES OF NON-VOTING COMMON STOCK OF THE PAR VALUE OF \$1.00 PER SHARE: ALL OF SAID STOCK TO BE HELD, SOLD AND PAID FOR AT SUCH TIME AND IN SUCH MANNER AS PROVIDED FOR IN THESE ARTICLES, AND IN THE BY-LAWS OF THIS CORPORATION. AND AS THE BOARD OF DIRECTORS MAY FROM TIME-TO-TIME DETERMINE. ALL CAPITAL STOCK, WHEN FULLY PAID, SHALL BE NON-ASSESSABLE. (b) THE CORPORATION SHALL HAVE THE POWER TO ADOPT BY APPROPRIATE BY-LAWS, A PROVISION OR PROVISIONS RESTRICTING THE SALE OR TRANSFER OF SHARES OF STOCK, PROVIDED THAT THE SAME SHALL BE IN ACCORDANCE WITH APPLICABLE LAWS.
