ARTICLES OF INCORPORATION RECEIVED

The undersigned, acting to incorporate a corporation under the Islahon Business.

Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is Fox Communication Corporation.
 - 2. DURATION: The period of its duration is perpetual.
