These Restated Articles of Incorporation correctly set forth without change the corresponding provisions of the Articles of Incorporation as theretofore amended and these Restated Articles of Incorporation supersede the original Articles of Incorporation and all amendments thereto.

The name of this corporation is:

(a) The purpose for which the corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

(b) The period of duration for this corporation shall be perpetual.

(c) The name of the registered agent for the corporation is Larry J. Hill and the address of the registered office is 435 W. Center, P.O. Box 1447, Pocatello, Idaho 83204.

(d) The total authorized number of par value shares and their aggregate par value is \$50,000, divided into fifty thousand shares of the par value of \$1.00 each.

(e) That all of said shares of stock shall be common stock.
