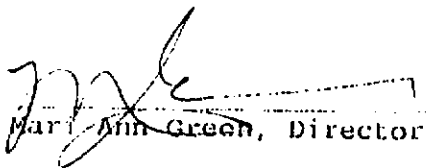
Further Resolved, that the effective date of this action by the Board of Directors shall be, and the same hereby is, October 4, 2011.

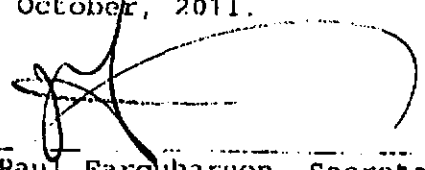
