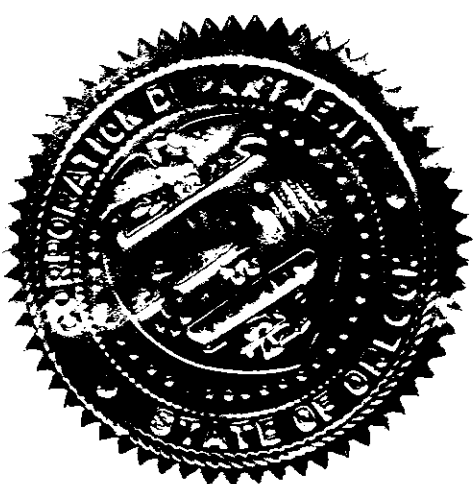

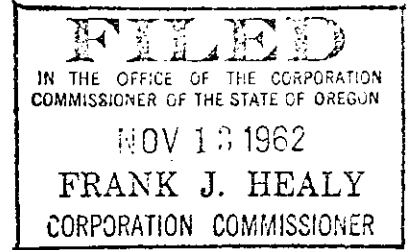

## Articles of Incorporation
