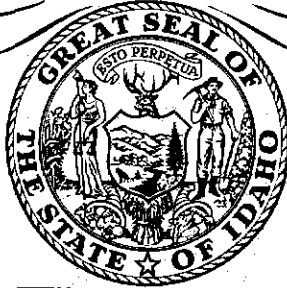

### CERTIFICATE OF QUALIFICATION OF FOREIGN CORPORATION

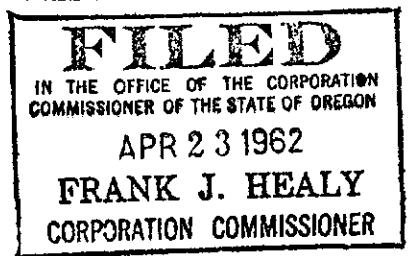

## Articles of Incorporation

OF

DAN DAVIS CORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

### ARTICLE I

① The name of this corporation is Dan Davis Corporation

and its duration shall be perpetual

### ARTICLE II

① The purpose or purposes for which the corporation is organized are:

To invest in real and personal property of every character and description; to erect buildings and other structures; to engage in the general business of contracting and engineering, and to manufacture and furnish buildings materials and supplies connected therewith; to perform services for the maintenance of real and personal property; to engage in the general insurance business; and to generally engage in any business activity incidental to any of the foregoing businesses.

ARTICLE III

- ⑨ The aggregate number of shares which the corporation shall have authority to issue is six hundred thousand (600,000) shares without par value.

The preemptive right of shareholders to acquire additional or treasury shares of stock in this corporation is expressly denied.

ARTICLE IV

The address of the initial registered office of the corporation is 1975 S. W. 5th Avenue,

and the name of its initial registered agent at such address is Dan Davis

ARTICLE V

The number of directors constituting the initial board of directors of the corporation is three,
