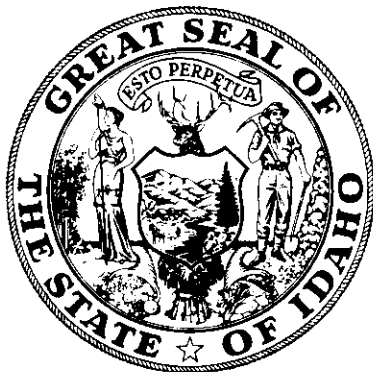
NORTH IDAHO BASS CLUB, INCORPORATED

ARTICLES OF INCORPORATION

OF

NORTH IDAHO BASS CLUB, INCORPORATED

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is NORTH IDAHO BASS CLUB, INCORPORATED.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The nature of the business and the objectives and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned as fully and to the same extent as natural persons might or could do, to-wit:

To encourage and stimulate interest in angling for bass; to improve techniques through tournaments; to perpetuate bass in waters adaptable to the species; to seek to procure better fishing for bass through efforts of this club and through cooperation with all other organizations or agencies with similar objectives; to assist in the observance and enforcements of game laws, and to fight pollution in all the waters of Idaho.

To do any or all of the things herein set forth to the same extent as natural persons might or could do in the

State of Idaho, either along or in the company with others, except as prohibited by the Idaho Nonprofit Corporation Act.

To conduct or transact any lawful business of any type for which a nonprofit corporation may be incorporated under the Idaho Nonprofit Corporation Act.

FIFTH: The corporation is to be a membership corporation having one or more classes of members as set forth in the Bylaws.

SIXTH: The members shall not be personally liable for the debts, liabilities or obligations of the corporation.

SEVENTH: The management of the affairs of the corporation is to be vested in its Board of Directors pursuant to Idaho Code 30-314.

EIGHTH: The initial registered office of the corporation is located at W. 3910 Hollister Drive, Post Falls, Idaho, 83854, with the registered agent being Roy H. Cook, at said address.

NINTH: The number of directors constituting the initial Board of Directors shall be three (3) and changes in the number of directors may be made pursuant to the Bylaws without amending these Articles of Incorporation. The Board of Directors shall consist of and be the same as the officers of the corporation. The names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify are:
