KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned
being a person of full age and being a citizen of the United
States, in order to form a corporation for the purposes hereinafter
stated, pursuant to the Business Corporation Act of Idaho, do
hereby certify that:

FIRST: The name of the corporation is ALPINE WOOD
PRODUCTS, INC.

SECOND: The purposes for which said corporation is formed
are: produce and manufacture wood products and the retail and
wholesale sale of wood products.

THIRD: The corporation is to have perpetual existence.

FOURTH: The corporation will do all banking transactions


