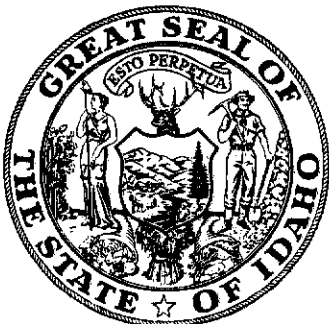

The undersigned, acting as incorporator under the Idaho Professional Corporations Act, adopts the following articles of incorporation:


