RE: Use of the Word "Credit Union" in Company Name in Idaho

Dear Ms. Palmer:

The Idaho Department of Finance (Department) received your email on March 3, 2025, seeking approval from the Department in order to use the name "Idaho Central Credit Union (ICCU)" to do business in Idaho and to register that business name and entity with the Idaho Secretary of State.

Section 26-2107 of the Idaho Credit Union Act (Act) prohibits any person, corporation, copartnership or association, except a credit union organized under the provisions of the Act or a properly authorized interstate credit union, to advertise or use as part of its company name the words "credit union" or any other words of similar import. Idaho Central Credit Union (ICCU) is organized under the provisions of the Act, so the Department does not object to your use and registration in Idaho of the business and entity name "Idaho Central Credit Union (ICCU)."
