## ARTICLES OF INCORPORATION

OF

## NORTH IDAHO BRIKCRETE COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify in writing:

I.

That the name of said corporation shall be NORTH IDAHO ERIKCRETE COMPANY, INC.

II.

That the purposes for which this corporation is formed are to manufacture and sell "brikcrete" and allied products; to manufacture and sell or use in the erection of structures "brik- crete" and allied products, and to manufacture, sell and use in construction concrete, pumice stone or light aggregate concrete materials, to engage in the business of buying and selling building products of all kinds, including lumber, hardware, glass, brick, concrete, plaster, plaster-board, electrical wiring, heating units, roofing and all other materials used in the repair or construction of buildings of any kind whatsoever. Also to purchase or otherwise acquire, or hold, lease, sell, exchange, assign, transfer, mortgage, pledge or otherwise dispose of, to guarantee and to invest, trade and deal in and with, real and personal property of every class and description; also to purchase, construct, lease or otherwise acquire, operate and maintain buildings and equipment in connection with the manufacture and sale of "brikerete" and

allied products, and all building materials of every kind whatsoever, and electrical appliances, refrigeration equipment; to purchase, lease or otherwise acquire lands for the purpose of erecting thereon manufacturing plant, office buildings, plants, work shops, dwelling houses, warehouses, stores, hotels and other buildings, to buy, sell and deal in goods, wares, and merchandise of every class and description, to own, acquire, hold, operate, use, develop, lease, sell, transfer and convey timber and timber lands, and gravel and sand pits, and to purchase, acquire, erect, construct, maintain and operate sawmills or gravel plants, or cement plants, or other factories for the manufacture of building materials and equipment, to purchase, locate, acquire by discovery, lease, license, option, franchise, grant, gift, devise or otherwise hold, possess, enjoy and develop, mine any mineral lands in Idaho or elsewhere, to borrow money, to make and issue notes, bonds, debentures, obligations, and evidences of indebtedness of every kind without limit as to the amount, and to secure the payment thereof by mortgage, deed of trust, pledge or otherwise, to make, enter into and perform agreements and contracts of every kind and description. To become if necessary a duly licensed insurance agent, insurance broker, carrying and selling all kinds of insurance; to build houses or other buildings of every kind and character, either for sale or lease or on contract or otherwise, to let, subdivide, re-sub-divide and plat tracts of lands and sell the same, either by sub-division or re-sub-division, and to improve plats laid out, grade and improve streets and alleys, construct and maintain sewers and any and all other conveniences and matters in connection therewith; to invest in, take over, buy, sell, pledge and exchange stock, shares, bonds and other securities of this or other companies whether incorporated or not; to hold, make advances

on, buy and sell on commission, sell or dispose of any of the investments aforesaid, or any real estate or products handled by this corporation, and to purchase or otherwise acquire, sell, assign, exchange, transfer, mortgage, pledge or otherwise dispose of shares of capital stock, bonds and securities issued or created by other corporations, and while the holders thereof, to exercise all of the rights and pledges of ownership, including the right to vote thereon; to engage in and conduct any and all kinds of manufacturing business, to remunerate any person or persons or corporations for services rendered to, or to be rendered in placing or assisting to place, or guaranteeing the placing of any shares of the company's capital stock or any other debentures or other securities of the company, or in the formation or promotion of the company or the conduct of its business; to do all other and such acts, things, business or businesses in any manner connected with, or necessary, incidental, convenient or auxilliary to any of the objects hereinbefore enumerated or calculated, directly \_ or indirectly, and that the purposes herein enumerated shall not be deemed to be exclusive, but/is hereby expressly declared that all other lawful powers not inconsistent herein are hereby included, and to exercise any and all corporate powers and rights in the State of Idaho, and in other states, territories and dependencies of the United States, and in the District of Columbia, and in any and all foreign countries.

## III.

That the amount of capital stock is Twenty-five Thousand (\$25,000.00) Dollars, divided into 12,500 non-assessable shares of preferred stock which shall entitle the holders thereof to receive out of the net earnings of the company preferential accumulated dividends at the rate of Five (5%) per cent per annum, payable annually on a date set by the Board of Directors, provided that said preferred stock shall be subject to redemption at the rate of One (\$1.00) Dollar per share and accumulated dividends thereon at any time after three years from the issue thereof, at such time or times and in such manner as the Board of Directors shall determine; and 12,500 shares of non-assessable common stock of the value of One (\$1.00) Dollar per share.

IV.

That the registered office of the corporation in the State of Idaho is the City of Kellogg, Shoshone County, State of Idaho, but branch offices may be established elsewhere, either within or without the State of Idaho.

٧.

The duration of said corporation shall be perpetual.

VI.

The number of directors of said corporation shall not be less than three (3) nor more than five (5) in number.
