## CERTIFICATE OF AMENIMENT OF ARTICLES OF INCORPORATION OF POWER COUNTY WHEAT LEAGUE, ENG.

We, the undersigned, Melvin G. Meadows and Storling W. Schow, respectively the president and secretary of Power County Wheat League, Inc., a non-profit corporation, do hereby certify that at a meeting of the members of said corporation duly called upon notice of the purpose of the meeting and held in American Falls, Power County, Edaho, on the 15th day of November, 1960, the assembled members of the Association, by a unanimous affirmative vote exceeding the two-thirds mejority required in the by-laws of the Association, adopted resolutions which read as follows:

"RESOLVED, That Article I of the Articles of Incorporation of the Power County Wheat League, Inc., be, and the same is hereby amended to read as follows:

## "ARTICLE I.

"The name of this corporation shall be the POWER COUNTY WHEAT GROWERS! ASSOCIATION, INC.

"RESOLVED FURTHER That the president and secretary of this Association be and they are hereby authorised and directed to make, execute and acknowledge a certificate to be filed and recorded in the manner required by law."
