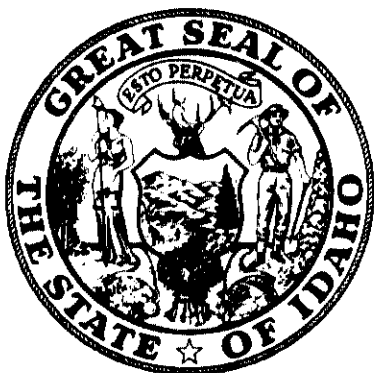

ARTICLES OF INCORPORATION OF
MISS RODEO IDAHO, INC.

THE UNDERSIGNED, acting as incorporators of a nonprofit corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such nonprofit corporation.

FIRST: The name of the corporation is Miss Rodeo Idaho, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the nonprofit corporation is organized are: All the purposes permitted a nonprofit corporation under the Idaho Nonprofit Corporation Act including, but not limited to:

(a) Preparation for contestants to compete in the Miss Rodeo Idaho pageant.

(b) Formulate rules for fair and safe competition among the contestants.

(c) Have and to exercise any other powers necessary to effect the provisions of (a) and (b) above.

FOURTH: Provisions for regulation of the internal affairs of the corporation shall be bylaws adopted and amended from time to time by members and/or the Board of Directors, and the number of votes required to amend the bylaws by the Directors shall be 66 2/3% of the directors elected.

FIFTH: The address of the initial registered office of the corporation shall be 570 Blue Lakes Boulevard, Twin Falls, Idaho, and the name of the initial registered agent at such address is Alan Greenway.



