ARTICLES OF INCORPORATION

URIA GROCERY INCORPORATED

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, each of whom is a bona fide resident and citizen of the State of Idaho, and of the United States of America, and each of whom is a natural person of full age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

## ARTICLE I.

THAT the name of this corporation shall be:

### ARTICLE II.

THE objects and purposes for which this corporation is formed are: as principal, agent or otherwise, to do in any part of the world any and every of the things herein set forth to the same extent as natural persons might or could do. In furtherance, and not in limitation, of the general powers conferred by the laws of the State of Idaho, we do expressly provide that the corporation shall have power:

(a) To carry on a general mercantile business, wholesale and retail in goods, wares and merchandise of all kinds and/or nature whatsoever and more particularly to carry on the business of buying and selling groceries, dry goods, clothing, utensils and other articles usually bought and sold by general stores and to do and transact everything necessary, proper and beneficial in carrying out any of the foregoing named objects.

- (b) To buy, sell, acquire, hold, own, mortgage, pledge, lease, assign, transfer, trade and deal in and with all kinds of personal property, goods, wares and merchandise of every kind, nature and description.
- (c) To purchase, own, sell, convey, mortgage, pledge, exchange, acquire by operation of law or otherwise, real property of every kind and character, for the use and benefit of said corporation.
- (d) To borrow and lend money from and to any person, firm, association, and to make, take and execute notes, mortgages, bonds, deeds of trust, or other evidence of indebtedness, for the use and benefit of said corporation.
- (e) To acquire by purchase, subscription or otherwise, and to own, hold, sell, negotiate, assign, deal in, transfer, mortgage, pledge or otherwise dispose of any shares of the capital stock.
- (f) To enter into, make, perform and carry out contracts of every king, amount and character with any persons, firm, association or corporation.
- (g) In addition to the foregoing powers, also to have all aughority, power and rights granted by the laws of the State of Idaho, and particularly Section 30-114 of the Idaho Code, and any amendments thereof.

### ARTICLE III.

The registered office of this corporation and the principal place for the transaction of its business is hereby designated as; 121 2nd Avenue East, Gooding, Gooding County, Idaho.

# ARTICLE IV.

This corporation shall have perpetual existance.

### ARTICLE V.

The number of directors of this corporation shall be not less than three

(3) in number.

#### ARTICLE VI.

The amount of the capital stock of this corporation is One Hundred and Twenty shares of no-par stock and said stock shall be non-assessable.

### ARTICLE VII.

The amount of the capital stock actually subscribed is three shares by the persons whose residence and the amounts subscribed herein are set forth.
