ARTICLES OF INCORPORATION  
OF J. W. COPELAND YARDS, INC.

We, the undersigned natural persons of full age, all of whom are citizens of the United States acting as incorporators for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, adopt the following Articles of Incorporation:

Article I

The name of this corporation is J. W. COPELAND YARDS, INC.

Article II

The purposes for which the corporation is organized are:

- (a) To engage in the business of buying, manufacturing and selling lumber and lumber products, building materials and all other kinds of merchandise.
- (b) To engage in and conduct any form of manufacturing or mercantile enterprise.
- (c) To acquire by purchase, lease, exchange or otherwise any and all real or personal property necessary or convenient for the operation of or in connection with this corporation's business; to lease and maintain buildings; to sell, lease, exchange or otherwise dispose of all said real and personal property and all the rights and privileges owned by it or in which it may have an interest.
- (d) To acquire by purchase or otherwise, and to hold, develop, market, sell and dispose of, interests in patents, and to have the title thereto registered in the name of this corporation; to acquire, hold and sell rights and interests in copyrights and trade-marks.

(e) To conduct the business of this corporation and to acquire, hold and sell property in other states and territories of the United States of America.

(f) To purchase, subscribe for or in any manner acquire, to sell, transfer or in any manner dispose of, and to exercise all the rights of individual natural persons with respect to shares of stock of and interests of any kind in corporations, partnerships, associations and joint stock companies, including its own stock.

(g) To do and perform all acts and things that may be necessary, convenient or profitable in the carrying out of the purposes of this corporation.

### Article III

The duration of the corporation shall be perpetual.

### Article IV

The location and post office address of the corporation's registered office in this state is 711 $\frac{1}{2}$  Bannock Street, Boise, County of Ada, Idaho.

### Article V


The total authorized number of shares is 1,000, each of which has a par value of \$100 and the aggregate par value of which is \$100,000.


