The undersigned, George Pascua, being a person of full legal age, does hereby form a domestic corporation under and pursuant to the laws of the State of Idaho, and does hereby certify:

FIRST: The name of this Corporation shall be "GEORGE'S ELECTRIC, INC.".

**SECOND**: This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho including, but not limited to the operation of a residential and commercial electrical contractor.

**THIRD:** The period of existence and duration of the life of this Corporation shall be PERPETUAL.

FOURTH: The location and address of the initial registered office of the Corporation in the State of Idaho shall be 7608 Spring Drive, Nampa, Idaho 83687. The initial registered agents of the Corporation shall be GEORGE PASCUA.

**FIFTH:** This Corporation is authorized to issue one class of share of capital stock to be designated as common stock. The total number of the shares of said common stock shall be authorized to issue is 1,000. The stock shall have \$100 par value.
