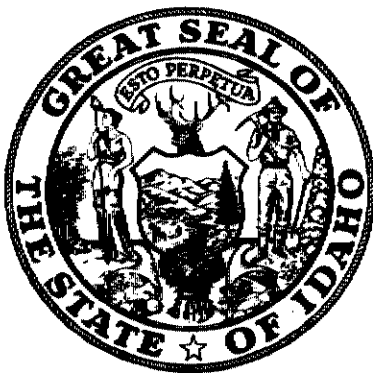

These articles of Corporation are for the Corporation named: Our Unchanging Hope Ministries Inc..It is a non-profit Corporation,and it will exist perpetually.

Our Unchanging Hope Ministries Inc. exists: To disseminate the Gospel of the Lord Jesus Christ by: Radio broadcasts;Bible Study Groups;and Printed Religious Literature. The Bible Study Groups will have members. Each member will have one vote,in deciding the location and time of Bible Study. A simple majority will carry the vote.All members will recive a monthly report and a annual report of all finances. All members will have the right to examine the financial records at any time.All other decisions pertinent to the Corporation is vested in the office of the President of the Corporation.

Our Unchanging Hope Ministries Inc. will not have a board of directors. All power is vested in the office of the President of the Corporation. Who is Rev.Dr. Clell A. Newell. Whose duties are as follows:(1) To produce and deliver all radio broadcast messages;(2) To buy additional broadcast time from local radio stations;(3)To produce and teach Bible lessons in various towns in the Panhandle of Northern Idaho;(4) To recruit and train teachers for the Bible Study Groups; (5)To write and have printed various religious literature for free distribution; (6)To purchase needed office equipment and to approve all

purchases made for the Corporation;(7)To see that all finances are kept in a orderly manner;(8)To sign all checks that are written as the second signature.

The second office of the Corporation is the office of Secretary-Treasurer. My wife Mary G. Newell will fill this office. The duties of the Secretary-Treasurer are as follows:(1)To maintain a bank account for the Corporation;(2) To maintain a bookkeeping ledger,showing all moneys received and disbursed;(3)To sign all checks as the first signature of each check: (4)To produce a monthly statement of all moneys received and disbursed; (5) This statement will be sent to each member of the Bible Study Groups on a monthly basis;(6) To prepare an annual report of all moneys received and disbursed.This yearly statement will be sent to all members of all Bible Study Groups,by the 15th of each July of each year;(7) To send out by the 30th of each January a contribution statement to each member of the Bible Study Groups,who contribute to the ministries,of the Corporation.
