ARTICLES OF INCORPORATION

> We, the undersigned, natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the Utah Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is WESTERN GENERAL CONST., INC.

ARTICLE II - DURATION

The period of its duration is perpetual.

ARTICLE III - PURPOSES

The corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be organized under this Act, including but not limited to:

> To enter into any lawful arrangement for sharing profits, union of interest, reciprocal association or cooperative association or cooperative association with any corporation, association, partnership, individual or

other legal entity for the carrying on of any business and to enter into any general or limited partnership for the carrying on of any business.

- (b) To guarantee the obligations of others with or without consideration.
- (c) To generally engage in the business of fabricating and erecting structural steel.
- (d) To engage in the construction business as a general contractor, both as to structures and as to roads and other earth moving undertakings.
- (e) To engage in any business in which a natural person could engage.

ARTICLE IV -- STOCK

The aggregate number of shares which the corporation shall be authorized to issue is 100,000 shares of the par value of \$.10 per share. All stock of this corporation shall be of the same class, common, and shall have the same rights and preferences. Fully paid stock of this corporation shall not be liable to any call and is non-assessable.

ARTICLE V - PRE-EMPTIVE RIGHTS

A shareholder shall have no pre-emptive rights to acquire any securities of this corporation.

ARTICLE VI - INITIAL CAPITALIZATION

This corporation will not commence business until consideration of a balance of at least \$1,000.00 has been received for the issuance of shares.
