ARTICLES OF INCORPORATION SECRETARY OF STATE

OF

ST. VINCENT DE PAUL VILLAGE HEIGHTS, INC.

The undersigned, for the purpose of forming a corporation under the Idaho General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be ST. VINCENT DE PAUL VILLAGE HEIGHTS, INC.

ARTICLE II

COMMENCEMENT OF EXISTENCE AND DURATION

The corporation shall be deemed to commence its existence on the date of filing. The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The purpose of the corporation shall be to transact any and all lawful business for which corporations may be incorporated under the Idaho General Corporation Act.

ARTICLE IV

CAPITAL STOCK

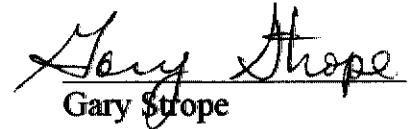
