

Pursuant to the General Power of Attorney dated the 6th day of October, 2009 granted in my favour by Tata Consultancy Services Limited ("Company"), a company incorporated under the Companies Act, 1956, and by virtue of the authority conferred upon me in terms of the said Power of Attorney to delegate specific powers contained therein, I hereby delegate to you the following powers to be exercised for and on behalf of the Company in respect of matters and business under your charge:

- a) To attend and participate as a representative of the Company, in meetings conducted by Clients, Government and Semi-Government bodies.
- b) To represent the Company, sign Business Proposals on behalf of the Company and to discuss, negotiate and finalise such Business Proposals.
- c) To represent the Company and to discuss, negotiate, finalise and sign with clients Agreements and Contracts for selling products and providing services of the Company PROVIDED that the value of such agreements / contracts do not exceed USD 10 Million or its equivalent in any currency.

- a) Contracts with total contractual revenue to the Company in excess of USD 100 Million or its equivalent in any currency
- b) Contracts that do not exclude liability for consequential and punitive damages as per standard requirements
- c) Contracts without a monetary cap on total liability
- d) Contracts that have non-compete provision restricting the Company from pursuing business in any area.

- d) To ensure that all Business Proposals, contracts and agreements for selling products and providing services of the Company conform to the pricing policy and credit policy of the Company and are in compliance with the enacted regulations (including transfer pricing regulations) of the local authority / government.
