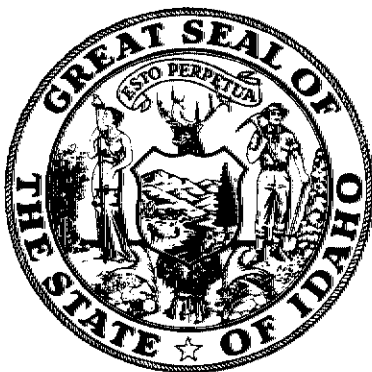

ARTICLES OF INCORPORATION

OF

GEM COUNTY ROD & GUN CLUB, INC.

The undersigned, acting as incorporators of a Non-Profit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is GEM COUNTY ROD & GUN CLUB, INC.

SECOND: This corporation is a non-profit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose or purposes of for which the corporation is formed are:

To operate and maintain trap shooting; to own, operate and maintain trap shooting apparatus; to acquire, hold, own or lease real property or sites within the State of Idaho and maintain the same as shooting grounds, and to execute mortgages or other evidences of indebtedness thereon, and to sell or otherwise dispose of such real property; to purchase, contract for, lease, and in any and all other ways acquire, hold, and own personal property necessary or convenient for the equipment and maintenance of shooting grounds, and to sell or otherwise dispose of such personal property; to purchase for an sell to members of this corporation sporting goods and supplies; to encourage the propagation, protection and distribution of game animals, birds and fish within the State of Idaho; to prescribe rules and regulations for the admission to and continuance of membership in this corporation; to adopt and use a corporate seal which may be altered at the pleasure of the corporation; and to do any one or more of the acts and things herein set forth, and generally to do and perform all things of whatsoever kind or nature pertaining to or connected with the purposes for which this corporation is organized.

FIFTH: The corporation shall have members.

SIXTH: The management of the affairs of the Corporation is vested in the Board of Directors of the Corporation. The initial registered agent shall be E. C. Rood.
