All remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.


ARTICLE VII

ARTICLE VIII


This dissolution is being taken pursuant to the unanimous written consent of the shareholders and pursuant to the Resolution to dissolve adopted as required by the Idaho Code.
