

ARTICLES OF INCORPORATION OF FRESH BEGINNINGS, INC.

The undersigned, as the incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

- 1. Name of Corporation. The name of the corporation is Fresh Beginnings, Inc..
- 2. <u>Period of Duration</u>. The period of duration of the corporation is perpetual, unless sooner dissolved by action of the shareholder or by operation of law.
