**ARTICLES OF INCORPORATION
OF
CHILD SUPPORT ENFORCERS, INC.**

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Child Support Enforcers, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of common shares which the corporation shall have authority to issue is 100,000, of which 2,000 shall have voting rights and 98,000 shall not have voting rights. The shares shall have no par value.

FIFTH: The address of the initial registered office of the corporation is 610 W. Hubbard, Suite 131, Coeur d'Alene, Idaho, 83814, and the name and address of its initial registered agent is: Michelle Westerlake, 610 W. Hubbard, Suite 131, Coeur d'Alene, Idaho, 83814.



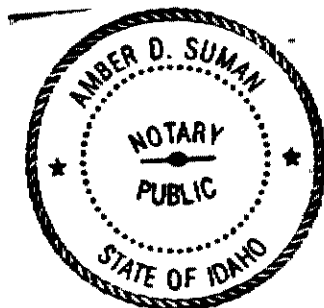
