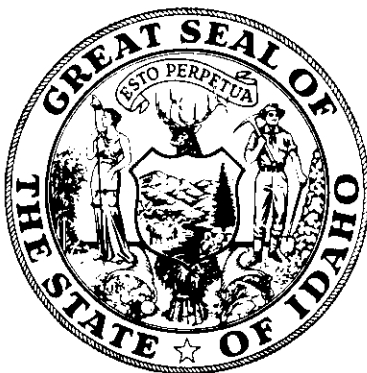

ARTICLES OF INCORPORATION  
FOR  
CBS MINING COMPANY

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I. Name. The name of the corporation is CBS MINING COMPANY.

ARTICLE II. Purposes. The purpose of the corporation is to engage in the business of a general prospecting, exploration and mining development corporation. In addition, the purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporations Act.

ARTICLE III. Duration. The period of duration of the corporation is perpetual.

ARTICLE IV. Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of Idaho is 4565 Clover Meadows, City of Meridian, County of Ada, 83642. The name of the corporation's initial registered agent at such address is Colt Macdonald Wright.

ARTICLE V. Stock. The total authorized number of shares is thirty-thousand (30,000) which shares are without par value. All shares of the corporation are common shares; there are no preferred shares.

ARTICLE VI. Initial Shareholders. The initial number of shares authorized in the Articles of Incorporation is hereby granted outright to the incorporators as follows:

1. Ten thousand (10,000) shares to Robert George Lukes
2. Ten thousand (10,000) shares to John Scott Carlson
3. Ten thousand (10,000) shares to Colt Macdonald Wright

Said shares are granted in consideration of past and/or anticipated future services already performed or to be performed by the aforementioned incorporators for the benefit of or on behalf of the corporation.
