(c) The notice required by section 30-1-87, Idaho Code, was given, in that the corporation has no known actual or potential creditors to whom notice could be given.


(d) All debts, obligations, and liabilities of the corporation have been paid and discharged.


(e) All the remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.
