The undersigned, acting as sole incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is Yew Tree Natural Products, Inc.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are:

To identify, evaluate, harvest, process, store and transport wood, wood products and derivatives, directly and/or through contractual arrangements, to use, sell and export such products, to carry on studies, investigations and research activities and to engage, generally, in any business and business activity that may be lawfully carried on by a corporation organized under the laws of the State of Idaho.

FOURTH:

The aggregate number of shares which the corporation shall have authority to

issue is 100,000, with a par value of one cent (\$.01) per share.
