Attachments to Articles

To the Secretary of State of the state of Idaho,

Article 2: The purpose for which the corporation is organized is to promote pro-life, profamily and pro-freedom ideals in public life. In addition, this corporation shall be authorized to conduct any other activities which may be carried on by a non-profit corporation under the laws of the state of Idaho.
