ARTICLES OF AMENDMENT

The Lewiston Roundup Association, Inc., an Idaho corporation, doing business in Nez Perce County, Idaho, on April 11, 1984 at a meeting of the membership of the corporation duly called, notice of which was given per the laws of the State of Idaho and further per the terms of the by-laws of the Lewiston Roundup Association, Inc., that which a quorum of the members of the corporation were present, by a majority vote, passed the following amendments of the Articles of Incorporation of the Lewiston Roundup Association, Inc.:

Paragraph 2(b) be deleted and that the following paragraph be accepted in its place.

The purposes for which this corporation is organized to receive and maintain a fund or funds of real or personal property, or both, and subject to the restrictions and limitations as hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, testing for public safety, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws. withstanding any of the other provisions of the Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

That paragraph 9 be added as follows:

9. Provisions for the regulation of the internal affairs of the corporation, including provisions for distribution

of assets on dissolution or final liquidation are:

- a. No Private Benefit. No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, officer of the corporation, or any private individual, (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no member, trustee, officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
- b. Legislative and Political Activity. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publication or distribution of statements) and political campaign on behalf of any candidate for public office.
- c. Distribution of Assets upon Dissolution. Upon the dissolution of the corporation or the winding up of its affiars, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent laws.
