ARTICLES OF INCORPORATION
OF
IDAHO STATE MASTER BARBERS ASSOCIATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the provisions of Chapter 195 of the Idaho Compiled Statutes, and we do make, subscribe and certify the following articles of incorporation, to-wit:

ARTICLE I.

The name of this corporation is the IDAHO STATE MASTER BARBERS ASSOCIATION.

ARTICLE II.

The object of this Association shall be the elevation of the Barber profession in general.

To promote the passage of laws safeguarding the Barber profession, and to prevent the passage of laws detrimental to our interests.

ARTICLE III.

The principal office and place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho.

ARTICLE IV.

The term for which this corporation shall exist shall be fifty years from and after the date of its incorporation.

ARTICLE V.
