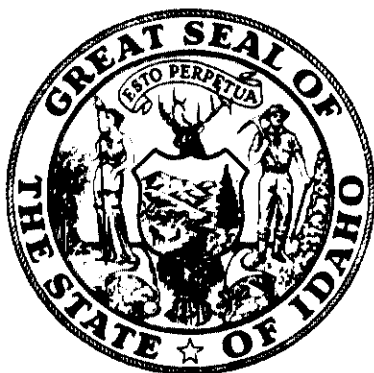

ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
FRIENDS OF CHANNEL 4, INC.

Pursuant to the provisions of Section 30-327 (1980) of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The name of the corporation is Friends of Channel 4, Inc.

SECOND:

The following amendments of the Articles of Incorporation were adopted by the members of the corporation on October 8, 1986 in the manner prescribed by the Idaho Non-Profit Corporation Act:

ARTICLE III

This corporation is organized as a non-profit corporation exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954.

The primary activity of the corporation shall be to ~~solicit and receive contributions of~~ money and ~~real and personal property from~~ public or private sources, and utilize said

monies and assets for the promotion and operation of public broadcasting through Channel 4 (and/or any successor channel) in Boise, Idaho, assist in publicizing KAID TV and securing financial support for the community to enrich and enhance and augment the programming of KAID TV. The Friends of Channel 4, through its Board of Directors, will consult with staff and management of KAID TV as to the probable effects of fund raising, programming and other activities requiring community and volunteer support. All funds received directly through on-air broadcast solicitation shall be placed in a Friends of Channel 4 corporate account, to which station personnel shall have unrestricted access.

THIRD:

No shares have been issued by the corporation.
